SCRIP PROGRAM

The mandatory \$300.00 Scrip profit will be based on the profit generated from Scrip purchased in your name between May 1, 2011, and April 30, 2012.

After your \$300.00 profit is met, a quarterly rebate based on 50% of the profit will be credited to your tuition invoice.

After May 15, 2012, any unused credit will return to the school and be placed in an account to be used for tuition assistance.

Only graduating OLM families may be issued a cash rebate.

DELINQUENT TUITION POLICY

1. Tuition is due and payable on the first of each month. A \$25.00 late fee will be assessed after the tenth of the month.
2. The administration will contact families with delinquent accounts that have not been resolved within sixty days.
3. The administration and/or pastor may refer delinquent accounts to the advisory school board.
4. Unpaid tuition may result in the child being released from school.
5. Families may not re-register their child until all tuition and fees are current.
6. Graduation Policy: All tuition and fees must be current. If not, students will not be permitted to participate in graduation activities.
7. Unless prior arrangements have been made, all delinquent tuition as of July 31, 2012, will be referred to a collection agency.

Registration Incentives:

2. Between March 23, 2011, and April 1, 2011, registration will be at a discounted rate of \$100.00 per child.
